These restricted stock units vest over a period of three (3) years, at 25% on each of the first two anniversaries of the grant and 50% on the third anniversary from the day of grant.
- The exercise price for the restricted stock unit exercise was \$84.83.
- Represents the 1st vesting anniversary (25%) of acquired restricted stock units granted pursuant to the 2018 Omnibus Incentive Plan, as amended.
- The exercise price for the cash-settled restricted stock unit exercise was \$84.83.
- Represents the second vesting anniversary (25%) of acquired cash-settled restricted stock units granted pursuant to the 2010 Omnibus Plan, as amended.
- The exercise price for the cash-settled restricted stock unit exercise was \$115.32.
- Represents the first vesting anniversary (25%) of acquired cash-settled restricted stock units granted pursuant to the 2010 Omnibus Plan, as amended.
